ARMASAFE™ PLUS LIMITED WARRANTY

The EnerSys/Hawker Armasafe[™] Plus batteries ("Product") are warranted by EnerSys Energy Products Inc. ("EnerSys") against defects in materials and in EnerSys' workmanship for eighteen (18) months from manufacturer's shipping date as indicated on the product label (the "Warranty Period"). EnerSys' sole obligation under this limited warranty shall be limited to the repair or replacement of the product, in its sole discretion. Such repair or replacement will be made only after EnerSys has examined the Product and determined, in its sole discretion, if such Product is defective in material or workmanship.

To enable such EnerSys examination of Product on which a claim is made under this limited warranty, the suspect Product should be returned to an EnerSys authorized facility pursuant to a Return Material Authorization (RMA) which can be obtained by calling EnerSys at the phone number above or by sending an email to the address above. EnerSys, in its sole discretion, may require proof of purchase consisting of a copy of the original invoice and proof of conformity with these terms and limitations. The acceptance of a Product shipped to EnerSys shall not be deemed an admission that the Product so shipped is defective. The Product shipped back to EnerSys, shall, in EnerSys' sole discretion, become EnerSys' property.

The Product must be charged, installed and maintained in accordance with the current Technical Manual published by EnerSys. Failure to do so will invalidate this limited warranty, at the sole discretion of EnerSys. Products that have been misused, abused, improperly stored, altered, or modified are not covered by this limited warranty. Abuse of Products includes using the Products in any electrical combination with non-EnerSys products. Products that have been repaired or attempted to be repaired by anyone other than EnerSys are not covered by this limited warranty. Products used in any electrical combination with non-EnerSys products are not covered by this limited warranty, and this limited warranty shall be rendered void for any Product used in such a manner.

THIS LIMITED WARRANTY IS IN LIEU OF, AND ENERSYS DISCLAIMS AND EXCLUDES ALL OTHER WARRANTIES, STATUTORY, EXPRESS OR IMPLIED, INCLUDING, WITHOUT LIMITATION, ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. ENERSYS' EXCLUSIVE LIABILITY FOR BREACH OF WARRANTY SHALL BE TO REPAIR OR REPLACE THE BATTERY WITHIN THE EFFECTIVE WARRANTY PERIOD, IN ITS SOLE DISCRETION. IN NO EVENT SHALL ENERSYS BE LIABLE FOR ANY LOSS OR DAMAGES OF ANY OTHER KIND, WHETHER DIRECT, INCIDENTAL, CONSEQUENTIAL, EXEMPLARY, SPECIAL OR OTHERWISE. NOR SHALL ENERSYS BE LIABLE FOR ANY REMOVAL OR INSTALLATION EXPENSE, OR THE LOSS OF TIME OR PROFITS. CUSTOMER ASSUMES RESPONSIBILITY FOR ALL PERSONAL INJURY AND PROPERTY DAMAGE RESULTING FROM THE HANDLING, POSSESSION OR USE OF THE BATTERY. IN NO EVENT SHALL THE LIABILITY OF ENERSYS FOR ANY AND ALL CLAIMS EXCEED THE PURCHASE PRICE OF THE BATTERY.

Some countries and/or states do not allow limitations on how long an implied warranty lasts or the exclusion or limitation of incidental or consequential damages, so the above limitations may not apply to User. This warranty gives the customer specific legal rights, which may vary from country to country and/or state to state. This warranty shall be governed by and interpreted in accordance with the laws of the State of Missouri without regard to Missouri's conflicts of laws rules.
